Candidates for state public office (as defined in T.C.A. §2-10-102) must file the original with the Registry of Election Finance, 404 James Robertson Parkway, Suite 1614, Nashville, TN 37243-1360. Candidates for the General Assembly also must file a copy with the county election commission of the candidate's residence.

Candidates for local public office (as defined in T.C.A. §2-10-102) must file ONLY with the county election commission(s) of the county or counties where the election is held.
